WHO WILL FOLLOW THIS NOTICE

All entities, sites, and locations of SacValley MedShare shall follow the terms of this notice. In addition, the entities, sites, and locations that access the information available on the SVMS HIE may share medical information with each other for treatment, payment, or healthcare operations purposes described in this notice.

OUR PLEDGE REGARDING MEDICAL INFORMATION

We understand that medical information about you and your health is personal. We are committed to protecting medical information about you. This notice applies to all your care records that are accessible through the SacValley MedShare Health Information Exchange.

This notice will tell you about the ways in which we may use and disclose medical information about you. We also describe your rights and certain obligations we have regarding the use and disclosure of medical information.

We are required by law to:

- Make sure that medical information that identifies you is kept private (with certain exceptions)
- Give you this notice of our legal duties and privacy practices with respect to medical information about you
- Follow the terms of the notice that is currently in effect

HOW WE MAY USE AND DISCLOSE MEDICAL INFORMATION ABOUT YOU

The following categories describe different ways that we use and disclose medical information. Not every use or disclosure in a category will be listed. However, all the ways we are permitted to use and disclose information will fall within one of the categories. Uses and disclosures not described in this Notice of Privacy Practices will be made only with authorization by you.

BREACH NOTIFICATION

If a breach of any of your protected health information occurs, you have a right to receive notice; we will notify you and provide instructions for further actions you should take, if any.

FOR TREATMENT, PAYMENT, AND OPERATIONS

We allow other participating members access to your medical information so that they can provide you with medical treatment or services. Medical information about you may be disclosed to doctors, nurses, technicians, healthcare students, or other personnel who are involved in taking care of you, operating their business, and making payments for your treatments.

AS REQUIRED BY LAW

We will disclose medical information about you when required to do so by federal, state, and/or local

SPECIAL SITUATIONS

PUBLIC HEALTH ACTIVITIES

Medical information about you may be disclosed for public health activities as permitted by federal, state, and local laws, rules, and regulations.

HEALTH OVERSIGHT ACTIVITIES

We may disclose medical information to a health oversight agency for activities authorized by law. These oversight activities include, for example, audits, investigations, and/or inspections.

LAWSUITS AND DISPUTES

If you are involved in a lawsuit or a dispute, we may disclose medical information about you in response to a court or administrative order. We may also disclose medical information about you in response to a subpoena, discovery request, or other lawful process by someone else involved in the dispute, but only if efforts have been made to tell you about the request (which may include written notice to you) or to obtain an order protecting the information requested.

YOUR RIGHTS REGARDING MEDICAL INFORMATION ABOUT YOU

You have the following rights regarding medical information we maintain about you:

RIGHT TO AN ACCOUNTING OF DISCLOSURES

You have the right to request an "accounting of disclosures." This is a list of the disclosures made of medical information about you for the purposes of treatment, payment, and health care operations, and with other exceptions pursuant to the law.

To request this list or accounting of disclosures, you must submit your request in writing to SacValley MedShare, 2485 Notre Dame Blvd. Suite 370-20, Chico, CA 95928. Your request must state a time period that may not be longer than six years. Your request should indicate in what form you want the list (for example, on paper or electronically). In addition, we will notify you as required by law if your health information is unlawfully accessed or disclosed.

RIGHT TO A PAPER COPY OF THIS NOTICE

You have the right to a paper copy of this notice. You may ask us to give you a copy of this notice anytime. Even if you have agreed to receive this notice electronically, you are still entitled to a paper copy of this notice.

CHANGES TO THIS NOTICE

We reserve the right to change this notice. We reserve the right to make the revised or changed notice effective for medical information we already have about you, as well as any information we receive in the future. COMPLAINTS

If you believe your privacy rights have been violated, you may file a complaint with SacValley MedShare or the Secretary of the U.S. Department of Health and Human Services. To file a complaint with SacValley MedShare, please send your complaint to: SacValley MedShare, 2485 Notre Dame Blvd. Suite 370-20, Chico, CA 95928. All complaints must be submitted in writing.

You will not be penalized for filing a complaint.
